Fees and Policies:

- 1. A nonrefundable application fee of \$75 is due with each application.
- 2. A \$300 deposit is due for each child after acceptance, along with a signed Enrollment Contract. This deposit is nonrefundable and required annually (see Enrollment Contract for Details).
- 3. Changes to the contract you sign must be submitted 1 month before any changes occur.
- 4. There is a materials fee for the Summer Program of \$50, due with June tuition.
- 5. A sibling discount of 10% applies toward the child with less tuition, this does not apply to extended day.
- 6. Extended day is from 7:00-8:30 and 3:00-5:30. Your extended day care can be modified on a monthly basis. A late fee will be charged for children not picked up by the contracted hour at the rate of \$1.00 per minute per child. Please see pricing above for details.
- 7. Drop-in care is available for \$15/hour, depending on staffing ratios.
- 8. Tuition payments are due by the first of the month; a \$25.00 late fee will be assessed after the fifth day of the month.
- 9. The amount of tuition for each program option at MVMS shall be determined annually by the Board of Directors.
- 10. In the case of a student entering MVMS after the opening date of the school year, the tuition will be calculated on a prorated basis, beginning on the child's specific entrance date.
- 11. Kindergarten students (5-6 year old, where the child is age 5 before September 1st) must enroll in the Full Day Kindergarten Program.
- 12. Scholarships may be available for students receiving CCAP Funding, for students on the CCAP waiting list, and for those students who qualify for free or reduced lunch and meeting the income guidelines of the program. A scholarship application form is due annually.
